



## Financial Assistance Policy Plain Language Summary

Johnson County Memorial Hospital, a not for profit critical access hospital, and the Family Medical Center, were established to serve the needs of the residents of Johnson County and surrounding areas. The hospital and clinic are committed to providing medical services to patients regardless of their ability to pay. Johnson County Memorial Hospital and the Family Medical Center recognize that not all patients have the financial resources to pay their hospital or clinic bills. This Plain Language summary provides basic information about our policy.

The Financial Assistance Program offers emergency and other medically necessary services at low or no cost to qualified patients. Patients must be a resident of Johnson County, WY. Whether patients are uninsured or underinsured, they can apply for financial assistance. Our Financial Assistance staff will assist individuals in applying for eligible government health insurance programs and completing the financial assistance application, free of charge.

The qualifying amount is based on the government's poverty levels for corresponding number of dependents in your household, and calculated from your gross income. Upon approval, patients may receive the following assistance:
